PRIVACY NOTICE ON THE PROCESSING OF PERSONAL DATA WITHIN THE DATA SUBJECT APPLICATION PROCESS

Pursuant to the Law on the Protection of Personal Data No. 6698 ("Law"), your personal data may be processed by TOFAŞ Türk Otomobil Fabrikası Anonim Şirketi ("**Company**") as the data controller, within the scope explained below.

Purposes and Legal Grounds for Processing Personal Data

Your personal data may be processed for the purposes ("**Purposes**") stated below, within the scope of the personal data processing conditions and purposes set out in **Article 5 of the Law**.

On the legal ground that processing is explicitly stipulated by law and necessary for the data controller to fulfill its legal obligations:

- Evaluating and concluding the applications you have submitted to the Company in accordance with your rights set out under Article 11 of the Law regarding the personal data processed by our Company, and carrying out the necessary actions in compliance with the legislation,
- Retaining the records of your applications to our Company during the general statute of limitations in order to serve as evidence in potential future disputes,
- Fulfilling requests from official authorities and providing information to authorized entities as required by legislation.

On the legal ground that data processing is necessary for the legitimate interests of the data controller, provided that it does not harm the fundamental rights and freedoms of the data subject:

- Following up and conducting legal proceedings.

To Whom and For What Purpose Processed Personal Data May Be Transferred

Your personal data collected in line with the Purposes stated above may be transferred, within the scope of our legitimate interests, to our attorneys and consultants from whom we receive legal advisory services, to our suppliers related to your application, and, limited to the notification requested in case you have demanded rectification or destruction of data, to the relevant parties to whom the data were transferred, pursuant to Article 11(1)(f) of the Law; and, for the establishment, exercise, or protection of a right, as well as the fulfillment of

our legal obligations where explicitly required by law, to legally authorized public institutions, including the Personal Data Protection Authority, and to legally authorized private persons, in accordance with the personal data processing conditions set out in Article 5 and the transfer provisions in Article 8 of the Law.

Method of Collecting Personal Data

Your personal data are collected within the scope of fulfilling the Purposes stated above, electronically or physically, through the data subject application form, petition letters, and e-mail correspondence submitted to our Company.

Rights of the Data Subject under Article 11 of the Law

Pursuant to Article 11 of the Law, you have the following rights regarding your personal data:

- To learn whether your personal data are processed,
- If your personal data have been processed, to request information in this regard,
- To learn the purpose of processing your personal data and whether they are used in accordance with their purpose,
- To know the third parties to whom your personal data are transferred domestically or abroad,
- To request correction of your personal data if they are incomplete or inaccurate, and to request that such correction be notified to third parties to whom the personal data have been transferred,
- To request the deletion or destruction of your personal data within the framework of the conditions stipulated in the Law, and to request that such deletion or destruction be notified to the third parties to whom the personal data have been transferred,
- To object to any result arising to your detriment through the analysis of processed personal data exclusively by automated systems,
- To request compensation for damages in case you suffer loss due to unlawful processing of your personal data.

Your requests regarding your rights listed above may be submitted to our Company by filling out the Data Subject Application Form available at [Protection of Personal Data](#) link. Our Company will conclude the request as soon as possible and at the latest within thirty (30) days, free of charge depending on the nature of the request. However, if the process requires an additional cost, a fee will be charged according to the tariff determined by the Personal Data Protection Board.
